The purpose of having a dinner with our meeting is to enjoy social and fellowship time between members, which was very much a tradition with the GAR.



### Wisconsin before the War

Wisconsin in the 1860's was still in many ways the pioneer state it was when it achieved statehood only a dozen years before. The northern part of the state was heavily forested and lumber towns grew up long the rivers that provided transport for the products of the forest.

The southern and central prairies provided good farmland for the growing of wheat. Wisconsin ranked second, behind Illinois, in wheat production. In 1860, the wheat harvest reached over 27 million bushels. Dairy farming had not made the inroads that it would in the 1880's and 90's as the railroads opened land and markets to the fragile products of dairying and so the familiar late summer, early fall cattle feed crops played a smaller role consideration of "harvest-time".

In the area known as the "driftless" area, because it was missed by the Wisconsin glacier of 15,000 years prior, were pockets of lead. The area is also known as the "galena" area since galena is Latin for lead. Lead mining the areas of Grant County, especially around Platteville, brought many immigrants, specifically, Cornish and Welsh to the area. Ironically Grant County, that supplied the Union Army a high proportion of its male population to the war, also supplied a large amount of the lead to the same effort and in effect playing out the mines.

What would lead almost 95,000 men out a population of 745,000 people to leave hearth and home to serve a cause that was half a country and seemingly a whole culture away?

The political climate leading up to the war cannot be underestimated. The state was a hot bed of Abolitionist sentiment. Places like Janesville and Waukesha were in fact stops on the Underground Railroad to Canada.

The editor of The Free Democrat (later The Waukesha Freeman) Sherman M. Booth, who took a leading part in a courthouse meeting, rode up and down the streets on a white horse summoning the people to gather, shouting the rallying cry: "Freemen, to the rescue!" according to popular account of the affair. Booth was jailed for rescuing an escaped slave named Joshua Glover from the Milwaukee County jail on March 11, 1854.

In defending himself in front of the U.S. Court Commissioner, Winfield Smith, Booth said "I am frank to say," he declared with emphasis--"and the prosecution may make the most of it--that I sympathize with the rescuers of Glover and rejoice at his escape. I rejoice that, in the first attempt of the

slave-hunters to convert our jail into a slave-pen and our citizens into slave-catchers, they have signally failed, and that it has been decided by the spontaneous uprising and sovereign voice of the people, that no human being can be dragged into bondage from Milwaukee. And I am bold to say that, rather than have the great constitutional rights and safeguards of the people--the writ of habeas corpus and the right of trial by jury-stricken down by this fugitive law, I would prefer to see every federal officer in Wisconsin hanged on a gallows fifty cubits higher than Haman's."

"The Glover episode and attendant circumstances were potent factors in creating an abolition sentiment in Wisconsin. In 1857 the legislature enacted a law "to prevent kidnapping," its purpose being to prevent the capture of fugitive slaves seeking asylum in this state."

In 1860, Gov. Randall, in his address to a joint session of the Legislature, stated his case for a peaceful settlement of the question of slavery through law.

"....There is no right of interference with slavery in the Slave States by legislation in the Free States, tending to its abolition, or by citizens of the Free States through a violent intervention. But the government was formed for the declared purpose of "preserving the blessings of Liberty," among other things, and not for the purpose of extending slavery. The colonies which so urgently denounced the evils of the institution and so strongly complained of the slave trade, now, erected into states, seek to force upon free territories the evils of a system they then deplored, by planting slavery where the Fathers of the Republic never intended it should go...."

"...An institution so inhuman, so pernicious in its character, so disastrous to the interests of free labor, and terrible in its consequences to the bondmen, and so antagonistic to the great principles of human liberty that underlie our government, ought, by the exercise of every legitimate power, to be restrained from any further extension..."

"...Shall the mighty States of this hemisphere the pioneers of the liberal principle of the greatest good to the greatest number—be known to the red and black races, struggling into existence, under liberal forms of government, in neighboring climes, suited to their caste, only as depredators and enslavers? They seem to have been committed to our guardianship by the gracious Providence that has conferred so many blessings upon us in the achievement of our own liberties."

His intent in the speech seemed to remind his audience of how deeply the institution of slavery put the expansion of the states in jeopardy, and ran against the basic unpinning of our nation.

Gov. Randall believed that if Lincoln did not gain the Presidency, Randall planned to propose secession from the union.

To drive the point home, it was reported in the March 10, 1860 The Daily Milwaukee News, that:

"Gov. Randall has sent a special communication to the Legislature, asking them to so amend the militia law, as to give him the power to compel the citizen soldiery, to fight the United States with arms which the United States Government itself has furnished them with, for a very different purpose. That would be a good joke on Uncle Sam."

In the opening session of the Legislature, "The Report of the Adjutant General shows 55 volunteer military companies, embracing 2,365 rank and file.

Gov Randall had the state adjutant meet with militia leaders to see who would support this move, and all but the Third Ward Irish Union Guard supported Randall's proposal. The whole proposal of course became mute when Lincoln was elected as President and Randall threw his support to the Union as the mechanism to abolish slavery.

## OSHKOSH and the OLD ABE Camp

In 1885 the Old Abe Camp, located in Oshkosh, was the largest SUV camp in Wisconsin. Old Abe was the famous mascot of the 8th Wisconsin Infantry, popularly known as the Eagle Brigade, a unit heavily involved in the campaigns of the western armies. Old Abe the battle eagle became a real war hero - used for recruiting during the war's later years, attending veterans reunions for years after, and finally becoming a National icon for Wisconsin.
